

Eligibility Guidelines for the New Jersey American Water H2O Help to Others Program™

About the Program

New Jersey American Water and SHARES have partnered to provide a program to help New Jersey households afford their water and wastewater bills. Eligibility is based on household size and income. Customers can qualify for a grant of up to \$500 through the H2O Help to Others Program provided they have residential accounts with New Jersey American Water, have a household income that is below 300% of the Federal Poverty Level and have fulfilled at least 50% of the payment terms set by New Jersey American Water. All grant payments are issued directly to New Jersey American Water on the customer's behalf.

Eligibility Guidelines

Households MUST:

- Have an active residential account with New Jersey American Water.
- Reside at the service address listed on the utility bill.
- Have arrears on their New Jersey American Water bill.
- Have made a good faith payment of at least \$100 (cumulative) within 90 days of application date.
- Not have defaulted on a payment plan with New Jersey American Water.

Households MAY:

Receive one grant of up to \$500 within a revolving 36-month period, applicable to water, wastewater, or combined services. Wastewater-only customers are eligible; however, no household may receive more than one grant during the 36-month period.

Income Eligibility:

Household income must be at or below 300% of the Federal Poverty Level. **See chart on Page 2.**

8 people / \$0 - \$13,930

For households greater than 8 people,
add \$1,420 per additional person

Policies and Procedures

Residence and Billing

- NJ American Water will reject multi-dwelling account applications – no exceptions.
- Account holder and all household members must reside at the service address listed on the utility bill. A family member, spouse or significant other can apply for assistance provided they reside in the home.
 - If multiple names appear on the utility bill, and are not disclosed on the application, we will require additional documentation

Status with New Jersey American Water

- The customer must have received a shut-off notice or currently be shut-off to be considered for a grant.
- A good faith payment of at least \$100 (cumulative) on their account within the last 90 days of the application date. If a good faith payment has not been made within the previous 90 days of the application date, the payment must be made first. The payment must clear and be posted to the account before New Jersey American Water can verify payment has been made.
- Customers with a balance of less than \$100 or above \$500 will be rejected.
- Grants will be used for monthly water or wastewater services only – not for deposits, leaks, reconnection fees, repairs, etc.
- Grants must restore or maintain service.
- No customer will receive a credit balance.

Required Documentation

SHARES must receive these documents within 14 days of the application date to process an application

Assistance Received (Categorical Eligibility)

If a household has received assistance within the current year from any of the programs below, they **must** provide the benefit/determination letter received instead of providing income and ID for the household if they choose to apply this way.

- Lifeline Communications Program
- Medicaid
- Supplemental Security Income (SSI)
- Supplemental Nutrition Assistance Program (SNAP)
- Work First New Jersey – Temporary Assistance to Needy Families (TANF)
- Veteran’s Pension
- Veteran’s Survivor’s Pension

If a household has received assistance within the current heating season from any of the programs below, they **may** provide the DCA application number (not required) received instead of providing income and ID for the household if they choose to apply this way.

- Low-Income Home Energy Assistance Program (LIHEAP)
- Universal Service Fund (USF)

If a household has received assistance from any of the programs below within the current calendar year, they **may** provide the SHARES application number (not required) received instead of providing income and ID for the household if they choose to apply this way.

- New Jersey American Water Universal Affordability Discount Program

Personal ID for the Applicant and All Household Members (Applicable only if no other assistance listed on the previous page has been received and applying by income)

Any unexpired government issued ID. ID must be provided for the applicant and all household members. If an adult (18 and older) household member’s ID shows a different last name than applicant, additional proof of residency is required. If the address is listed on the ID provided and it does not match the service address, additional proof of residency is required.

Proof of Residency

If any documentation provided throughout the application process includes an address that does not match the service address, further proof of residency will be required. To prove residency, additional documentation dated within 30 days of the application date showing name and address must be provided.

Proof of Income (Applicable only if no other assistance listed on the previous page has been received and applying by income)

Proof of the last four consecutive weeks of income from the date of the application for all household members ages 18+. Any household members ages 18+ without income should be listed on the online application or Zero Income Affirmation form, if applying with paper. The Zero Income Affirmation should be signed by the applicant.

Proof of income includes:

Most Recent New Jersey American Water Bill

Provide the most recent water and/or wastewater bill to include all pages. This information is verified with New Jersey American Water.

Completed, Signed and Dated Application

- The application must be signed and dated.
- If a volunteer, family member, or social worker is completing the application for an account holder that is elderly or disabled and unable to complete the application on their own a Power of Attorney document or letter of authorization will be required.
